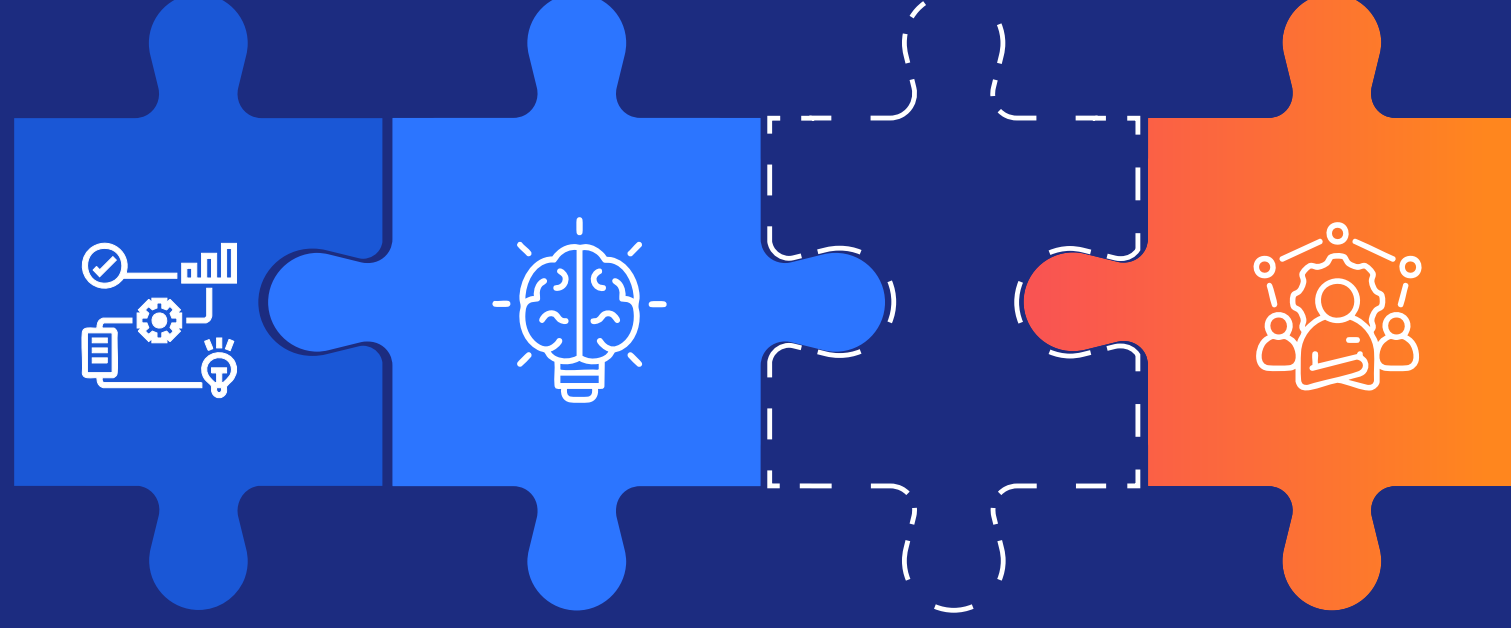


Utilities are being asked to modernize faster, scale smarter, and keep the system running without disruption.

AI is a strategic priority. Modernization is non-negotiable.



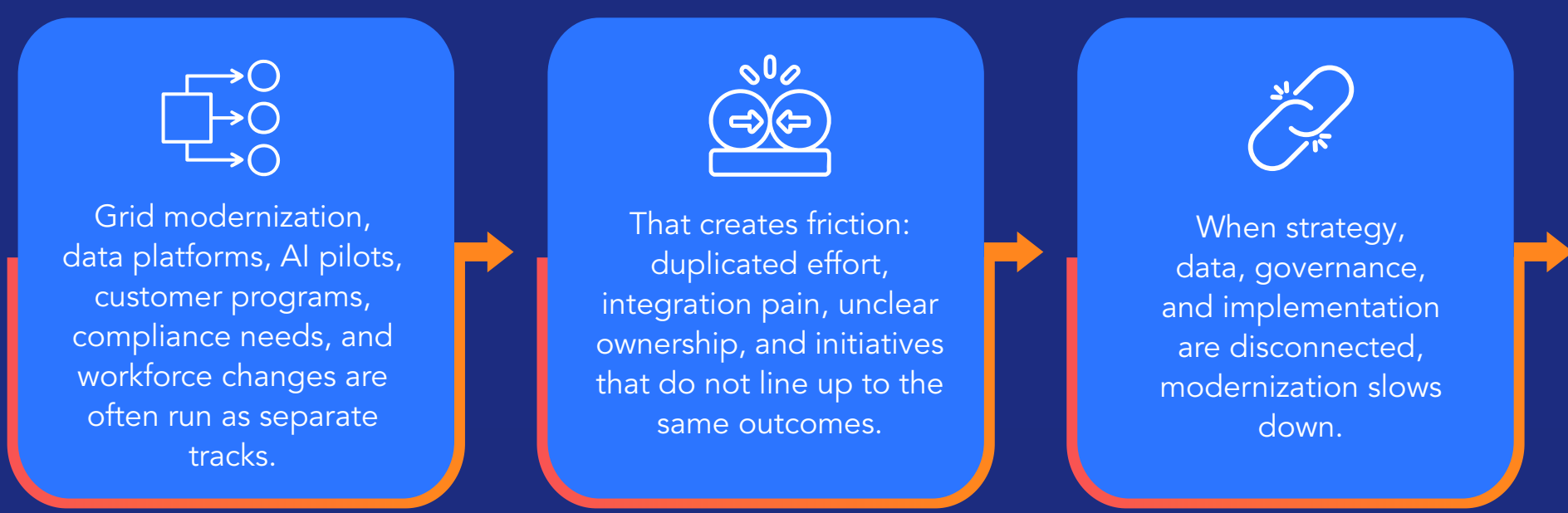
AI and modernization roadmaps exist: grid analytics, asset health, forecasting, customer engagement, virtual power plants.

AI and modernization efforts are happening in parallel, not together.



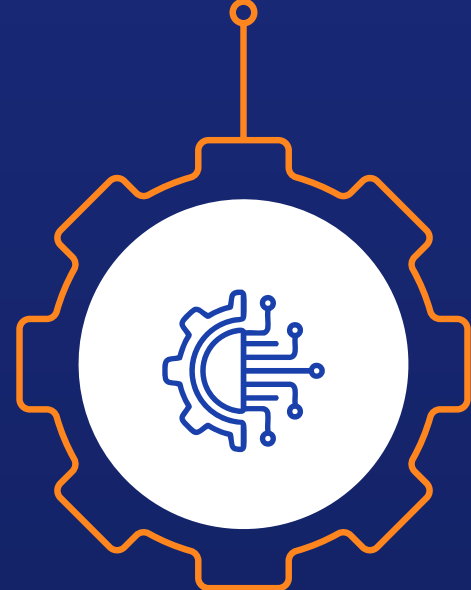

AI won't scale if it's treated as just a tech project.

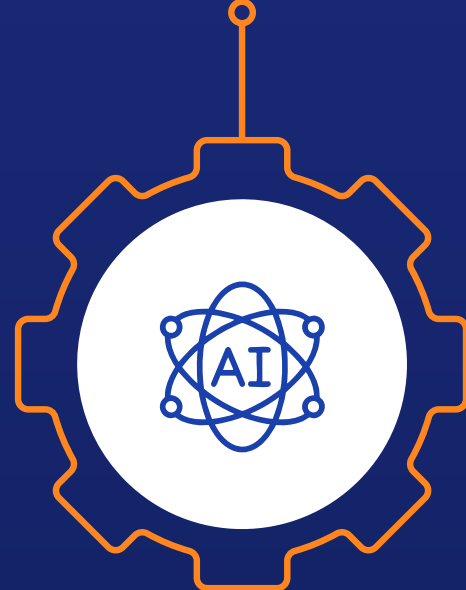
From modern data platforms and AI/ML to integration across business and operational systems, technology is critical.
